## After your contract is complete

Following the completion of your contract, Assure will issue your Building Regulations Compliance Certificate within 5 working days. An example of this certificate is detailed on the right.

This confirms that your installation was carried out by a member of Assure in compliance with Building Regulations. In addition, your Local Authority Building Control has been informed. You do not need to do anything further. You should keep this certificate in a safe place as your solicitor/ legal advisor would require this if you sell your property.

#### Selling your property

Should you decide to sell your property, your Assure Building Control Compliance Certificate is the only proof you will need to provide your solicitor/legal advisor to confirm the windows and doors the member installed comply with Building Regulations. ### Replacement windows and doors

Since April 2002, it has been a UK legal requirement that all replacement window and door installations conform to the relevant and current Building Regulations.

### Impact on selling your property

If you decide to sell your home, then your solicitor/legal advisor will ask you to provide a Certificate to prove that your new windows and doors comply with building regulations. Without this certificate your house sale could be held up. Using an installer registered with a Competent Person Scheme can help you avoid any unwanted delays or additional costs.

#### What is a Competent Person Scheme?

Competent Person Schemes (CPS) were introduced by the UK government to allow individuals and businesses to self-certify that their work complies with Building Regulations. This is an alternative to submitting a building notice or using an approved inspector.

A Competent Person Scheme must be approved by The Department for Communities and Local Government (DCLG) and accredited by UKAS. Schemes authorised by the DCLG are listed on its website at www.communities.gov.uk.

An installer registered with a Competent Person Scheme is gualified to carry out specific types of work in accordance with Building Regulations. The installer should notify the local authority of the work and issue you a certificate of 'compliance with Building Regulations' either directly or through their Competent Person Scheme.
